SNACK BAR CASH ACCOUNT AUTHORIZATION

The York Manor Swim Club (YMSC) Snack Bar Cash Accounts are a great way to use the Snack Bar without having to carry cash with you to the pool.

HOW DOES THIS WORK?

Your approved family members will be able to charge items to your YMSC Snack Bar Cash Account once it has been established. You, and family members you give your Cash Account ID # to, are responsible to remember your number. **We will be unable to process your orders without it.**

WHEN AND HOW DO I ESTABLISH AN ACCOUNT AND PAY?

Accounts are established at the beginning of the pool season on advertised days. Please complete and bring this form, along with the amount of cash you wish to establish an account with. Cash Accounts may be established with amounts between \$10 and \$100 at any given time. Please remember this is a cash only account – therefore, no checks, debit cards, or credit cards will be accepted at any time. Once an account has been set up, a Cash Account ID # will be issued. Due to the busyness of the Snack Bar on weekends, cash accounts will only be established or replenished on weekdays.

Items purchased and linked with your ID # will be tracked daily. Primary account holders are welcome to make inquiries regarding their Cash Account balance during the weekdays. When your Cash Account drops below \$5.00 you will be notified by email of the remaining balance and you will be given an opportunity to replenish it. No credits will be given. No monthly account summaries will be mailed out. All account cards will be secured each evening.

WHAT HAPPENS IF I DON'T USE ALL MY CASH BY THE END OF THE POOL SEASON?

All Snack Bar Cash Account balances must be closed (or zeroed out) one week before the last day the pool is open. If any cash remains in your account, then the YMSC will return it to the primary account holder by cash.
