

York Manor Swim Club: Assumption of Risk and Waiver of Liability
(Related to Coronavirus/COVID-19)

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

York Manor Swim Club has put in place preventative measures to reduce the spread of COVID-19; however, the York Manor Swim Club **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending York Manor Swim Club could increase** your risk and your child(ren)'s risk of contracting COVID-19.



By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending **York Manor Swim Club** and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the **York Manor Swim Club** may result from the actions, omissions, or negligence of myself and others, including, but not limited to, **York Manor Swim Club** employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the **York Manor Swim Club** or participation in **York Manor Swim Club** programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the **York Manor Swim Club**, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the **York Manor Swim Club**, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any **York Manor Swim Club** program.

I acknowledge and agree that the **York Manor Swim Club** may revise its procedures at any time based on updated recommended guidelines and protocols issued by the Maryland Local Government or Public Health Agencies and further agree to comply with the Club's revised procedures prior to utilizing the facilities.

I have carefully read and voluntarily sign this York Manor Swim Club: Assumption of Risk and Waiver Liability. I also understand that this Assumption of Risk and Waiver of Liability is on behalf of my minor child(ren). I represent and warrant to the **York Manor Swim Club** that I have full authority to sign this waiver on behalf of such minor(s).
